What is the overall <a href="#">deductible</a> ?	<b>\$6,000</b> /person or <b>\$12,000</b> /family for In- <a href="#">Network Providers</a> . <b>\$12,000</b> /person or <b>\$24,000</b> /family for Non- <a href="#">Network Providers</a> .	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive Care</a> for In- <a href="#">Network Providers</a> . Dental and Vision for In- <a href="#">Network</a> and Non- <a href="#">Network providers</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	<b>\$7,350</b> /person or <b>\$14,700</b> /family for In- <a href="#">Network Providers</a> . <b>\$14,700</b> /person or <b>\$29,400</b> /family for Non- <a href="#">Network Providers</a> .
