What is the overall <a href="#">deductible</a> ?	\$0/person or \$0/family for In- <a href="#">Network Providers</a> .	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the policy, the overall family <a href="#">deductible</a> must be met before the <a href="#">plan</a> begins to pay.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. Dental, <a href="#">Preventive Care</a> , Primary Care Visit, <a href="#">Specialist</a> visit, Tier 1a, Tier 1b, Tier 2, Tier 3 and Tier 4 <a href="#">Prescription Drugs</a> , and Vision for In- <a href="#">Network Providers</a> .
