What is the overall deductible?	\$500 /person or \$1,500 /family for In- Network Providers . \$1,000 /person or \$2,000 /family for Non- Network Providers .	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible?	Yes. Preventive Care , Primary Care Visit, and Specialist visit for In- Network Providers . Dental and Vision for In- Network and Non- Network providers .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . What is the out-of-pocket limit for this plan?	\$6,500 /person or \$13,000 /family for In- Network Providers . \$13,000 /person or \$26,000 /family for Non- Network Providers .
