<b>Are there services covered before you meet your deductible?</b>	No.	You will have to meet the <u>deductible</u> before the <u>plan</u> pays for any services.
<b>Are there other deductibles for specific services?</b>	Yes. For <u>prescription drug</u> expenses - In- <u>Network</u> : Individual \$750 / Family \$1,500. Does not apply to in- <u>network</u> for preferred generic drugs. There are no other specific <u>deductibles</u> . <b>What is the out-of-pocket limit for this plan?</b>	In- <u>Network</u> : Individual \$8,700 / Family \$17,400. **Does this plan provide Minimum Essential Coverage? Yes.**
