What is the overall <b>deductible</b> ?	\$0.	See the Common Medical Events chart below for your costs for services this <b>plan</b> covers.
Are there services covered before you meet your <b>deductible</b> ?	Yes. Primary Care <b>Specialist</b> Visit <b>Preventive Care</b> for In- <b>Network Providers</b> . Vision for In- <b>Network Providers</b> .	This <b>plan</b> covers some items and services even if you haven't yet met the <b>deductible</b> amount. But a <b>copayment</b> or <b>coinsurance</b> may apply.
