| Are there services covered before you meet your deductible? | Yes. Preventive care and services listed in your complete terms of coverage. | This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible. | Are there other deductibles for specific services? | No. | You don't have to meet deductibles for specific services. |

| What is not included in the out-of-pocket limit? | Copayments for certain services, premiums, and health care this plan doesn't cover. | Even though you pay these expenses, they don't count toward the out-of-pocket limit. |

You will pay less if you use a provider in the plan's network.
