

 The Summary of Benefits and Coverage (SBC) document will help you choose a health plan. Are there services covered before you meet your deductible? Do you need a referral to see a specialist?

Yes. An electronic referral is required to see a Network Specialist.

This plan will pay some or all of the costs to see a specialist for covered services but only if you have a referral before you see the specialist.
